PAID PARENTAL LEAVE	<b>H.R. 532:</b> Federal Employees Paid Parental Leave Act / Rep. ## OTHER BILLS OF INTEREST TO NARFE

The following bills targeting federal employees have been introduced in this Congress. They are not expected to get much action, so they have not been included in the Bill Tracker. However, it is important for NARFE members to be aware of the priorities of some in Congress.

- **H.R. 1230, the Government Employee Pension Reform Act of 2015**, introduced by Rep. Bruce Westerman, R-AR, would change the pension calculation from the high-3 to the high-5, effective January 1, 2017. The change would save \$3.1 billion over a 10-year period, according to calculations by the

Congressional Budget Office. No cosponsors.

- **H.R. 1137, the Promoting Accountability in Decisions for Progress Act (PAID for Progress Act)**, introduced by Rep. Tom Rice, R-SC, would cut salaries for all federal employees
